RE: Fargo-Moorhead Flood Risk Management Supplemental Environmental Impact Statement Preparation Notice

The Department of Natural Resources (DNR) will prepare a Supplemental Environmental Impact Statement (SEIS) for the Fargo-Moorhead Diversion Authority's proposal to make the following changes to the project:

- Relocate the dam/southern embankment and associated change in locations of the Red River and Wild Rice River control structures.
- Relocate the East and West tie-back levees. These relocations change approximately 10 miles of
 embankment construction footprint area. Under the revised project Wolverton Creek would now
 enter the Red River downstream of the dam. Based on this relocation of the eastern tie-back, the
 City of Comstock ring levee has been removed from the project.
- The revised project proposes that operations will not begin until the river stage at the USGS Fargo stream gauge is 37 feet. This would have a river discharge greater than 22,300 cfs. Additional intown measures would be needed to accommodate this flow through town. The previous project proposed to begin operation at 17,000 cfs, thus increasing the flow through town by 5,300 cfs under the revised project.
- The project will be evaluated using a 100 year flood event that is calculated with the full period of record.

Attached/Enclosed is a copy of the Preparation Notice for the SEIS. The Preparation Notice describes the Environmental Impact Statement being supplemented, the situation necessitating SEIS preparation, the scope of the SEIS, and the proposed time schedule for SEIS completion.
